1 I, JEFFREY D. LIGHT, declare as follows:

2 1. I am a member of the law firm of Robbins Geller Rudman & Dowd LLP ("Robbins
3 Geller"), one of Court-appointed Class Counsel in this Litigation. I am a member of the California bar
4 in good standing. I submit this declaration in support of the donation of the residual amount left in the
5 Net Settlement Fund that is not feasible to distribute to the Class Members to the Bay Area Legal Aid. I
6 have personal knowledge of the issues described herein, and if called upon, I could and would testify
7 competently thereto.


8 2. As set forth in ¶5.9 of the Stipulation of Settlement dated October 31, 2016, and as set
9 forth in the Notice of Proposed Settlement of Class Action, to the extent that, after the distribution(s) to
10 Class Members, there is a balance remaining in the Net Settlement Fund which is too small to distribute
11 to Class Members, Class Counsel will file a motion with the Court to donate the remaining money left
12 in the Net Settlement Fund (less any reserve for administration and/or tax expenses) to the Bay Area
13 Legal Aid.

14 3. To my knowledge, no attorney or staff member at Robbins Geller has a financial interest
15 in, serves on the Board or worked on any pro bono cases with the Bay Area Legal Aid. My knowledge
16 is based on sending a firm wide e-mail asking everyone at the firm to respond to my e-mail if they have
17 a financial interest, serve on the Board or worked on any pro bono cases with the Bay Area Legal Aid.
18 As a result of that e-mail, not a single person responded to my e-mail with a yes to any of my requests.

19 4. To my knowledge, the only connection with the Bay Area Legal Aid and Robbins Geller
20 is that in October 2006, Robbins Geller donated \$2,500.00 to the Bay Area Legal Aid.

21 I declare under penalty of perjury under the laws of the State of California that the foregoing is
